Adoption of Minutes

Mr. Blik moved, Mr. Hammond seconded and all members participating unanimously approved the following resolution:

RESOLVED, that the minutes of the October 25, 2022 meeting of the Audit Committee of the Wayne County Water and Sewer Authority be accepted with no changes.

2022 Financial Audit

Mr. Zuber from the office of Mengel Metzger Barr & Co., LLP, presented the financial documents and discussed the Financial Executive Summary, Internal Control Communication and Basic Financial Statements, which had been distributed via email prior to the meeting. He first reviewed the Financial Executive Summary with the Committee. Mr. Zuber then reviewed the Internal Control Communication, explaining the purpose of this part of the audit and reviewing its recommendations. During the discussion, Board members Dan LaGasse and David Scudder entered the meeting.

After due discussion and deliberation, Mr. Hammond moved, Mr. Blik seconded and all members participating unanimously approved the following resolution:

RESOLVED, to recommend that the 2022 Audited Financial Statements, including the Executive Summary and the Internal Control Communication as prepared by Mengel Metzger Barr & Co., LLP, be accepted and approved by the Authority Board, and following such approval and certification by the Chief Executive Officer/Chief Financial Officer of the Authority, such documents be filed with the Authority Budget Office and other designated recipients as required by the Public Authorities Accountability Act.

Mr. Zuber left the meeting.


